Since an order number will be/must have been sent to you upon registration for the further use as to the the payment procedure, please indicate this number when making the payment by bank transfer, the online payment will automatically proceed with the latter. Thanking all those of you who have already completed the registration and payment, those who only registered but did not yet pay, are hereby kindly reminded to assure the according payment asap!

Please also notice that, if you may be interested in securing your **accomodation at <u>Hotel Gio</u> being also the venue of the Conference**, availability of rooms at the hotel of the conference venue is now limited and thus advisable to make your booking as soon as possible.
