Annual Scientific Conference and Annual General Meeting 2018: Perugia, Italy – 17-19. October 2018

Dear Colleagues,

It was a great pleasure to meet many of you at this year's annual meeting in Perugia. We have enjoyed an interesting scientific programme with contributions from a wide variety of backgrounds. The theme, "***Fading of the HACCP after four decades: new trends in VPH for food safety***" was already highlighted in the first keynote presentation on HACCP. This was followed by a presentation on food safety in military operations, clearly having its logistical challenges. These keynotes were followed by four resident poster presentations, with interesting subjects on antimicrobial resistance, zoonotic surveillance and risk factors for *Toxoplasma* infections. Another keynote was presented on EFSA's approach to risk assessment of vector-borne diseases.

In the afternoon of the first day, three workshops were conducted, on the following subjects:

- The quantitative outcomes of a «one health» approach to study global health challenges: a joint residency project
- Science and policy: some examples
- Big data analysis in veterinary public health: from sequence analysis to risk assessment

The workshops were highly appreciated by the participants and continue to be an effective and interesting mode of transferring information and knowledge while keeping the minds busy.

In the morning of the second day, an interesting challenge session was presented on the controversial subject of raw milk. Obviously, the safety of the consumption of raw milk was given attention, but also the role raw milk might play in reducing allergies. Not surprisingly, the challenge session provoked quite a lot of debate, as a challenge session should!

Another residents session followed, with poster presentations on *Anisakis* larvae in herring, livestock-related microbial air pollution and challenges in organizing practical meat inspection training of veterinary students in Finland.

A final keynote presentation followed, on the control of brucellosis in less developed countries.

The closure of the conference saw the presentation of the '**Roberto Chizzolini Memorial Poster Prize**', which was won by **Dorien Eppink** for her poster on '[Association between within-herd seroprevalence and risk factors for *Toxoplasma gondii* in fattening pigs in The Netherlands](#)', and the presentation of the venue for the next meeting, Edinburgh.

I think we can look back at a very successful annual meeting, for which I would like to thank Beniamino Cenci Goga and Maria-Francesca Iulietto and their team. The conference was well organised, the catering was excellent as well. Leave that to the Italians!

I hope to see many of you again next year in Edinburgh!

Financial issues - Treasurers report summary

At the AGM in Perugia the Junior Vice-President Kurt Houf (former ECVPH Treasurer) presented the financial overview of the period August 2016 till 1. January 2018. The College is in good standing. Payments were done e.g. for the AGM in Liege, for taking the examinations and EBVS obligations. The auditors checked the accounts and had minor comments on how the accounts were handled.

Then the acting treasurer Len Lipman presented the present financial status of the College. This status is still good but some costs are exploding. Especially the website costs and the exam costs have risen a lot. On both subjects the ECVPH Council will start actions. For the website the Council will contact the website provider to discuss the risen costs. For the exam costs, the Council will ask other Colleges how they perform the exams to come up with a cheaper system, if possible, without diminishing the quality of the exams. If costs cannot be reduced the Council will propose a rise in fee costs at the AGM in Edinburgh. The also proposed possible rise in exam fee's was discussed by diplomates at the AGM. The assembly advised the Council to seek the solution, if necessary, in a rise in annual fees instead of a rise in exam costs since for some residents these costs are already extensive.

BREXIT update

The United Kingdom will formally leave the European Union in March 2019, but it is not leaving Europe. ECVPH's current position is to maintain a strong commitment to foster a welcoming and supportive environment for its diverse scientific network of European residents and Diplomates. This includes our EU and UK residents and Diplomates who are working or studying in the UK. Indeed, the EBVS remit extends to veterinary surgeons who **are licensed to practice in Europe**. So that also includes colleagues who work in European countries outside the EU and those graduating from schools that give them access to a European license to practice even if they do not work in Europe.

Given the highly dynamic nature of the UK's EU Exit negotiations, we will alert you if there are any significant changes to the EBVS or ECVPH position.
