Residency - Training issues

Dear Diplomates and Residents,

as you probably know there are some changes to the organization of the residency programs in the ECVPH (due to EBVS guidelines). For your convenience we are happy to recall main issues and summarize some important aspects of the residency training programs. Important to know is that for all currently running and approved residency program nothing is changing. **For all new residency programs** the rules as described below are applying.

There are two types of Residency Programs:

- A **Standard Residency Program** shall consist of a period of at least three (3) years (but not more than six (6) years) of supervised training, postgraduate education and practical experience in the science of Veterinary Public Health and including in-depth experience in one of its subspecialties. A Standard Residency Program shall be conducted under the direct supervision of at least one (1) Diplomate who participates actively in that training program and is **conducted in an approved Residency Training Institute**. A Residency Training Institute must be approved by the Education Committee. Each institution will be allowed a specified maximum number of Standard Residency Programs which will be evaluated and accepted by the Education Committee. **Applications have to be made according to Annex 1 of the [Bylaw on Residency training](#) at least three months in advance of the first residency commencing**. For the evaluation of a Residency Training Institute the Education Committee will assess the 1) supervision, 2) facilities, service and equipment and 3) courses. The requirements are not so difficult to achieve and relate to what was required in the past for the individual residency training programs. To set up an approved residency training institute collaboration between different organizations / locations is allowed and even stimulated.

So far the following three Residency Training Institutes have been approved to offer Standard Residency Programmes (SRP):

- University of Glasgow, School of Veterinary Medicine, Residency in PM subspeciality
 - Swedish University of Agricultural Sciences (SLU), Faculty of Veterinary Medicine and Animal Sciences both in PM and FS subspecialities and
 - The University of Edinburgh, Royal (Dick) School of Veterinary Studies both in FS and PM subspecialities

- An **Alternative Residency Program** shall consist of a period of at least four (4) years. During this time the amount of the applicant's time spent in the selected subspeciality is at least 60 %, subject to the discretion of the Credentials Committee. As for the Standard Residency Program, the maximum duration of the training period shall be no longer than six (6) years with the same rules for exceptions. The structure of such an Alternative Residency Programs will be modular, in order to create as much flexibility as possible and to facilitate rotation. Alternative Residency Programs must be conducted under the supervision of a Diplomate and one (1) of the four years must be spent under full-time supervision of a Diplomate or in a program that trains Veterinary Public Health specialists as one of its primary functions.

The XVIIth Annual General Meeting of the ECVPH will be held in the afternoon of Tuesday 3. October 2017 .

Diplomates are once more reminded that attendance of the AGM at least once in 3 consecutive years is compulsory, and that the status of Diplomates not complying with this requirement will be set to "non-practising".

Workshop attendants will exchange ideas and experience, establish common ground in research areas or practical problems. We would like to invite our Diplomates and the Residents to submit workshop proposals. This would be an opportunity to recognize expertise that we have within our College and hopefully identify new opportunities for collaboration and future activities. The workshop offered by the Diplomates and/or Residents that have been selected will be scheduled in the Conference program.

REMINDER: Re-evaluation of Diplomates in 2017

In 2017 Re-evaluation is compulsory for all Diplomates who received their diploma in 2001 and 2012 or before. A total of 15 Diplomates are affected. Diplomates being in the "non-practising" membership state need to start their Re-evaluation by initiating the Re-activation of their membership by a separate request to the ECVPH Council (see ECVPH e-Newsletter 1/2017!)

The re-evaluation will be based on the self-declaration of activities during the past 5 years. Activities are classified into six categories and credit points can be collected for specified activities. A total of 100 credit points needs to be reached. The status of Diplomates who do not achieve this target, who do not apply for re-evaluation, or who submit incomplete or delayed files will be set to "non-practising". As such, they will still have to pay the annual fees, but will not be allowed to vote, hold office nor use their title of Specialist. They will no longer be allowed to use their specialist title. The **deadline** for the submission of documents is **April 1, 2017**. - [Resident WS on "*\(Mathematical\) infectious disease models and socialnetwork analysis*", 17-19. May 2017, Berne/CH](#)

Organisers Objectives: The workshop will primarily address the curriculum's module A4 of the PM subspecialty on mathematical models. This module is assigned with a [P], thus practical experiences are highly recommended for its completion. We will combine theory and practice. We will also encourage residents to present their own work related to infectious disease mathematical and simulation models, so that they can profit from inputs on their research projects. Other modules partly covered are C3 from the core part I, where we will introduce and practice burden estimators (DALY, YLL and QALY), and C4 of the PM subspecialty where the part on network analysis based on tracking data will be introduced.
