For all those who have planned to attend and so far didn't register, please make sure to do so asap and notice the **deadline for "early-bird" registration being set to 5th of September 2017!**

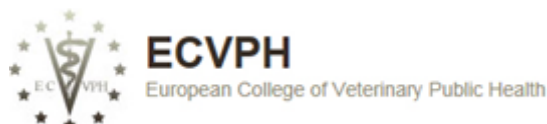
The Organisers and the Council of the ECVPH are looking forward to welcoming you in Liège in October!
